All product categories will be vetted by Beautiful Blooms Management Team. For the good of the Beautiful Blooms and its clientele, we reserve the right to deny any product category. **Product pricing is set by the vendor.**

Fees and Payment

*****To receive full season discount total vendor fee must be paid 1 week prior to opening weekend.*****

Active Vendor (handling their own payments) - \$10 per Saturday or \$90 for the Full Season (11 weekends paid in full prior to opening weekend).

Active Vendor (with Beautiful Blooms handling payments) - \$15 per Saturday or \$145 for the Full Season (11 Weekends, paid in Full prior to opening weekend). All products sold will be paid out at the end of the season.

For credit card purchases there will be an additional 4% fee to cover SQUARE fees.

Silent Vendor – (Beautiful Blooms handles products and payment.) Setup Cost: one time \$50 fee(covers the full 11 weeks) due by July 9th and a 90/10 split on all products sold. Product sales and Credit Card fees will be paid out at the end of the season. **For credit card purchases there will be an additional 4% fee to cover SQUARE fees.**

Vendors who are unable to attend a Saturday and provide 14 days advanced notice will be refunded their vendor fee.

If the 14-day notice is not able to be provided, the vendor fee will **NOT** be refunded.

HEALTH AND SAFETY

Vendors are responsible for the cleanliness of their space and must collect all trash and debris by the end of the day. Trash can be left on site in the appropriate receptacles.
